

Dartbrook Mine Environmental Protection Licence Monitoring Data

Dartbrook Operations Pty Limited is the operator of Dartbrook Mine.

Environmental Protection Licence (EPL) 4885 outlines the environmental management and monitoring requirements for Dartbrook Mine. The key licence details for EPL 4885 are presented in **Table 1**. EPL 4885 identifies three discharge/monitoring points, as detailed in **Table 2**. Monitoring of soil quality at the effluent irrigation area (EPL Point 5) is not required until the recommencement of effluent application at the premises.
